REPRESENTATIVE MATTERS

Representing public owners in construction disputes:

- Settled a \$14 million claim for \$1.1 million as lead counsel for a public owner in a wastewater treatment facility dispute.
- Settled an \$8.6 million claim for \$350,000 as lead counsel for a public owner in a construction dispute.
- Settled a \$5.6 million claim for \$1.95 million as lead counsel for a public owner in a bridge construction dispute.
- Successfully defended the appeal of the denial of a \$1.4 million general contractor claim.

Other Representations:

- Protected free speech and obtained an order of dismissal in client's favor in a defamation matter involving
 internet speech that implicated Section 230 of the Communication Decency Act, speech protected by the
 First Amendment, and Maryland's Anti-SLAPP legislation. This was the second Anti-SLAPP motion granted
 in Maryland in the 20 years since the promulgation of Maryland's Anti-SLAPP Statute.
- Obtained an \$8.7 million judgment as lead counsel for a commercial lender against a defaulting borrower and guarantors.
